Vision in Motion project update at Port Hope Conversion Facility



The Port Hope Conversion Facility will have some noticeable changes take place in 2022 as work continues on the Vision in Motion (VIM) project.

The most visible change will occur when scaffolding begins to be installed around Building 27 in preparation for the removal of the tower.

"The tower demolition won't begin until closer to the end of the year," said Shane Watson, program manager, stakeholder relations. "However, there is a lot of prep work involved in completing a job like that safely, so you will see scaffolding going up around the building to allow us to do this work."

The project will also see the demolition of the old hydrogen station as the new station comes online early in 2022.

Cameco facilities in Port Hope and Blind River granted licence renewals from the CNSC

The Canadian Nuclear Safety Commission (CNSC) announced on February 17, 2022 that Cameco Fuel Manufacturing (CFM) in Port Hope and the Blind River Refinery had both been granted licence renewals.

Cameco Fuel Manufacturing

CFM has been granted a oneyear renewal of its Fuel Facility Operating Licence. The renewed licence allows the facility to operate until February 28, 2023. Cameco purposely requested a one-year licence renewal in order to put the licencing activities for CFM out of sequence with the licencing process for the Blind River Refinery, which was scheduled to occur at the same time. While awaiting the one-year licence renewal, CFM applied to the CNSC on October 4, 2021, to renew the applied-for one-year licence, for an additional 20-year period.

Cameco expects the CNSC public hearing for the 20-year licence renewal to take place late in 2022. This process is expected to include interventions and the CNSC's Participant Funding Program will also be available. Blind River Refinery

The CNSC also announced that Cameco's Blind River Refinery has been granted a 10-year renewal of its Fuel Facility Operating Licence.

The renewed licence allows the Refinery to operate until February 28, 2032, at which time Cameco can request to renew the licence for another period. No changes were requested in the renewal and operations are expected to safely continue in the same manner. As part of the CNSC's public

licence renewal process, dozens of intervenors supported Cameco's application. Cameco also heard feedback and areas of interest about its operations, and we look forward to continued dialogue, actively engaging and making improvements.

Safety is at the core of Cameco's operations and activities, and throughout this renewed licence period we remain committed to the protection of people and the environment.
