

Cameco Port Hope – 2022 Public Opinion Survey Executive Summary


Highlights

On behalf of Cameco Corporation, Fast Consulting conducted a public opinion survey with residents of the Municipality of Port Hope in the summer of 2022. The annual survey monitors support for Cameco's local operations and gathers perceptions of the corporation. A survey sample of 402 residents lets us say with a 95% level of certainty that overall results are within plus or minus 4.9% of what they would be if the entire adult population of the municipality were polled. Data was weighted according to Statistics Canada Census data to ensure the sample matched Port Hope's age-based population.

Majority "Very Aware" of Cameco's Port Hope Operations

All respondents (100%) are at least somewhat aware of Cameco's Port Hope operations—and 81% are "very aware". Long-term tracking shows the majority of respondents consistently say they are "very aware" of Port Hope operations.


Awareness of Port Hope Operations, 2015-2022



9 out of 10 Are Supportive of Cameco

- Nine out of ten (93%) Port Hope respondents support the continuation of Cameco's operations in Port Hope—including roughly two-thirds (65%) who are "strongly supportive."
- Long-term tracking consistently shows that the large majority of survey respondents are supportive of Cameco continuing its operations in Port Hope.

Drivers of Public Support

- When respondents are asked the main reason they're supportive of Cameco continuing to operate in Port Hope, the largest percentage (45%) point to Cameco's contribution to the economy, jobs and tax revenue. This is consistently the number one reason residents support Cameco.
- Other reasons for support include the perception that Cameco is a good corporate citizen/good to community (21%) and support for nuclear/clean energy (10%).
- Among those not supportive of Cameco continuing to operate in Port Hope, the most frequently cited reasons are environmental impact (9%) and safety & health concerns (8%). This is also consistent with previous surveys.

Environment, Safety & Jobs Are Top-of-Mind Issues

When asked what types of issues are important to them when thinking about Cameco in Port Hope, environment (32%), community safety (24%) and jobs (15%) are top-of-mind. These three issues are consistently top-of-mind from survey to survey.

8 out of 10 Aware of Both Port Hope Facilities

> The large majority (84%) are aware that Cameco operates two facilities: the Port Hope Conversion Facility at the waterfront and Cameco Fuel Manufacturing on Dorset Street.

Majority Support Long-term Licence

> The large majority (82%) are supportive of Cameco Fuel Manufacturing's application to continue to operate in Port Hope over the next 20 years, including 66% "strongly supportive." The most frequently mentioned reason is the economic contribution of jobs and taxes to Port Hope (43%).

9 out of 10 Are Knowledgeable about Cameco

Nearly all (94%) of Port Hope respondents describe themselves as knowledgeable about Cameco, including 35% who describe themselves as "very knowledgeable".

Few Have Any Specific Concerns about Cameco

> Consistent with previous surveys, most (70%) do not have any specific concerns about Cameco's operations in Port Hope.

Majority Comfortable with Nuclear Operation in Port Hope

- The large majority (85%) agree that Cameco does everything possible to protect people and the environment—including half (53%) who "strongly agree."
- Nine out of ten (91%) agree that Port Hope is a safe and healthy place to live, including the large majority (73%) who "strongly agree." This is consistent with previous surveys.

Vision in Motion

- Four out of ten (43%) respondents are aware of Cameco's Vision in Motion plan. This has trended downward from 61% in 2017.
- Nine out of ten (93%) agree that Cameco's Vision in Motion plan to renew, clean up and modernize the Port Hope conversion facility is a step in the right direction and a benefit for Port Hope—including 69% who "strongly agree".
- Nine out of ten (90%) agree that turning over 7 acres of waterfront land in the harbour area to public use as part of Vision in Motion is a step in the right direction and a benefit for Port Hope—including 81% who "strongly agree".

Majority Think Cameco Makes Information Readily Available

- Respondents get information about local events from multiple media channels: 49% from letters/flyers/mail, 42% local newspapers, 32% websites, 25% Port Hope social media groups, 19% TV/radio, 18% community emails and 16% word of mouth.
- Most (79%) respondents agree Cameco makes information about its operations in Port Hope readily available to residents.

8 out of 10 Recall Receiving Cameco Newsletter

Most (77%) recall receiving a newsletter from Cameco. Of these respondents, 84% say they read some of the newsletters.

9 out of 10 Aware Cameco Invests in Port Hope

- ▶ 95% of respondents were aware, prior to the survey, that Cameco invests in the Port Hope area through sponsorships and other community initiatives.
- 92% are aware that Cameco regularly participates with the public through community events where residents can get information about Cameco and its operations.

2022 Trust Index Scores

Although Cameco receives operating licenses from federal and provincial regulatory bodies, to remain viable the company also needs a social licence to operate from the communities in which it exists. The Trust Index uses a series of questions about the company's performance regarding environmental responsibility, internal processes and community citizenship. Going forward, the trust index has been adjusted to include nine statements. Respondents rate their agreement with statements using a scale of 1 to 10, where 1 is 'do not agree at all' and 10 is 'strongly agree'.

Together, these statements form the Trust Index. Measures are in the "very good to excellent" range in all four areas: environment, workplace, innovation and community. Overall trust scores are up compared to 2021 and 2020.

- INNOVATION: 8.54 vs. 8.19 in 2021 and 8.35 in 2020
- WORKPLACE: 8.48 vs. 7.96 in 2021 and 8.13 in 2020
- COMMUNITY: 8.12 vs. 7.91 in 2021 and 8.10 in 2020
- ENVIRONMENT: 7.75 vs. 7.44 in 2021 and 7.51 in 2020

9 out of 10 Aware of Nuclear Energy's Role in Ontario

- ▶ 90% of respondents are aware nuclear energy provides more than half of the electricity generated in Ontario, including 71% who are "very aware".
- > 88% are aware nuclear reactors are a low carbon emitting source of electricity that is increasingly seen as part of the solution to climate change, including 68% "very aware".
- > 86% are aware all nuclear reactors in Ontario use uranium processed by Cameco in Port Hope, including 62% "very aware".

Methodology

In the summer of 2022, our firm conducted the annual public opinion survey with residents of the Municipality of Port Hope to monitor support for Cameco's local operations and gather perceptions regarding the corporation. The survey was in the field from July 27th to August 14th.

The sample included 402 Port Hope and area residents and was done by landline and mobile telephone. Elemental Research (Ottawa) conducted the telephone interviews. The survey questionnaire includes baseline questions asked in previous years, allowing us to monitor changes in public opinion and perceptions over time.

The survey sample frame is constructed to obtain interviews from a random selection of households in the Municipality of Port Hope, which consists of two wards. Ward 1 is the urban sector with the majority of commercial and industrial development. It was the former Town of Port Hope prior to amalgamation in 2001. Ward 2 is the former Hope Township and consists of several hamlets including Welcome, Campbellcroft, Garden Hill and Perrytown.

The overall margin of error for a probability-based telephone survey with a random sample of 402 respondents is +/- 4.9%, with a 95% confidence interval (19 times out of 20). Margins of error are greater for smaller sub-groups within the sample.

Awareness of Cameco Port Hope

Q1. We're interested in your opinion regarding a company called Cameco Corporation, a nuclear energy company that operates two facilities in Port Hope. The Port Hope conversion facility processes uranium that is used to generate clean electricity here in Canada and around the world. Cameco Fuel Manufacturing manufactures nuclear fuel bundles and other component parts for the Canadian-designed Candu nuclear reactors.

Would you say you are very aware, somewhat aware or not at all aware of Cameco's Port Hope operations?


 All respondents (100%) are at least somewhat aware of Cameco's Port Hope operations—with the large majority (81%) saying they are "very aware" of the operation.

 Long-term tracking shows consistently high awareness of Cameco's Port Hope operations, with the majority consistently saying they are "very aware" of the operation.


Awareness of Port Hope Operations, 2005 - 2022



Important Issues

- Q. What types of issues are important to you when you think about Cameco in Port Hope?
- When people are asked what types of issues are important to them when thinking about Cameco in Port Hope, the environment, safety, waste management and jobs are consistently top-of-mind.
- In 2022, approximately a third (32%) of respondents say the operation's environmental impact is important to them (vs. 28% last year and 35% the year before). Also linked to environment, approximately a fifth (20%) cite waste management as an important issue (vs. 16% in 2021 and 22% in 2020).
- Approximately a quarter (24%) say community safety issues are top-of-mind, unchanged from the previous two years.
 Also, 12% cite workplace safety issues (12% vs. 13% in 2021 and 9% in 2020).
- The percentage who cite jobs as an important issue has decreased from 28% in 2020 to 15% in 2022.
- Other frequently mentioned issues include health concerns (9%), community support (8%), economic diversification/tax revenue (8%) and being open and transparent (6%).

Environment, Safety, Jobs Remain Top-of-Mind Issues




Support for Port Hope Operations

- Q. Would you say you are strongly supportive, somewhat supportive, somewhat unsupportive or not supportive at all of the continuation of Cameco's operations in Port Hope?
- Nine out of ten (93%) respondents support the continuation of Cameco's operations in Port Hope—including roughly twothirds (65%) who are "strongly supportive."
- Long-term tracking consistently shows that the large majority of survey respondents are supportive of the continuation of Cameco's operations in Port Hope.

9 out of 10 Support Cameco's Continued Operation in Port Hope




Support for Cameco Continuing Port Hope Operations, 2005 - 2022



Reasons for Support

- Q. What would you say is the main reason you are supportive or not supportive of Cameco continuing to operate its facilities in Port Hope?
- The largest percentage (45%) of respondents who support the
 continuation of Cameco operating in Port Hope say it's because
 of Cameco's contribution to the economy, jobs & tax revenue.
 Although down from 56% and 58% of mentions in 2021 and
 2020 respectively, this is consistently the number one reason
 residents support Cameco.
- Other reasons for supporting Cameco's continued operation in Port Hope are that it's a good corporate citizen/good to community (21%) and support for nuclear/clean energy (10%).
- Approximately 7% are supportive because they see Cameco as a safe company and 6% because they think Port Hope would suffer if the company left.
- Among those not supportive of Cameco continuing to operate in Port Hope, the most frequently cited reasons are worries about the environmental impact (9%), safety & health concerns (8%), perception the operation is destroying the waterfront (5%) and waste disposal/clean-up concerns (4%).

Economic Impact Remains #1 Driver of Public Support



Awareness of Port Hope Facilities

- Q. Are you aware that Cameco operates two facilities: the Port Hope Conversion Facility at the waterfront and Cameco Fuel Manufacturing on Dorset Street? (New question in 2022)
- The large majority (84%) of respondents are aware that Cameco operates two facilities: the Port Hope Conversion Facility at the waterfront and Cameco Fuel Manufacturing on Dorset Street.
- Approximately 10% are only aware of the Port Hope Conversion facility, while 3% are only aware of Cameco Fuel Manufacturing.
- Another 3% indicated they were not aware of Cameco facilities.


8 out of 10 Aware of Both Port Hope Facilities



Support for 20-Year Application to Operate

- Q. Cameco Fuel Manufacturing has submitted an application to the Canadian Nuclear Safety Commission to renew its licence for a period of 20 years. Would you say you are strongly supportive, somewhat supportive, somewhat unsupportive or not supportive of Cameco Fuel Manufacturing's application to continue to operate in Port Hope over the next 20 years? (New question in 2022)
- The large majority (82%) of respondents are supportive of Cameco Fuel Manufacturing's application to continue to operate in Port Hope over the next 20 years. This includes 66% who are "strongly supportive."


8 out of 10 Support Long-term Licence



Reasons for Supporting / Not Supporting 20-Year Application

- Q. What would you say is the main reason why you feel this way about Cameco's application for a license to operate its facilities in Port Hope for the next 20 years? (New question in 2022)
- Respondents have many reasons for supporting Cameco's application for a license to operate its facilities in Port Hope for the next 20 years.
- The most frequently mentioned (at 43% of respondents) is the operation's economic contribution of jobs and taxes to Port Hope.
- Other frequently mentioned reasons include the perception of Cameco as a safe company (17%) and a good corporate citizen/good to the community (14%).
- Other reasons include the perception that the Port Hope facility has been there a long time and nothing has happened (9%), which can be tied to safety, and the perception that Port Hope would suffer if Cameco left (7%), which can be tied to the operation's economic impact.
- Among those not supportive of Cameco continuing to operate in Port Hope for another 20 years, the most frequently cited reasons are worries about the waste disposal/clean-up (7%), environmental impact (7%), safety & health concerns (6%) and a perception the operation is destroying the waterfront (6%).

Economic Benefit Key Driver of Long-term Support




Knowledge of Port Hope Operations

- Q. Would you describe yourself as being very knowledgeable, somewhat knowledgeable or not really knowledgeable at all about Cameco?
- Consistent with previous surveys, the large majority (94%) of Port Hope respondents describe themselves as knowledgeable about Cameco, including 35% who describe themselves as "very knowledgeable" and 59% as "somewhat knowledgeable."
- Since respondents were first asked this question in 2007, nine out of 10 have consistently self-described as being "somewhat to very knowledgeable" about Cameco.

9 out of 10 Are Knowledgeable about Cameco




Knowledgeable about Cameco, 2007 - 2022



Specific Concerns

- Q. Do you have any specific concerns with the presence of Cameco's operations in Port Hope?
- The majority of respondents (70%) do not have any specific concerns about Cameco's operations in Port Hope, in line with previous surveys.
- The most frequently mentioned concerns are also consistent with previous surveys; namely, that Cameco operations are destroying the waterfront (9%), health & safety of residents (8%), waste management/clean-up (8%), leaks/water contamination/dumping (5%) and worried about environmental impact (4%).

7 out of 10 Have No Specific Concerns about Cameco






Cameco Protects People & Environment

- Q. Do you agree or disagree that Cameco does everything possible to protect the people and the environment of Port Hope?
- The large majority of respondents (85%) agree that Cameco does everything possible to protect people and the environment—including half (53%) who "strongly agree."
- Over the past decade, the large majority of respondents have consistently agreed that Cameco does everything possible to protect people and the environment.

Large Majority Agree Cameco Protects People & Environment




Agreement that Cameco Protects People & Environment, 2012 - 2022




Port Hope as Safe, Healthy Place to Live

- Q. Do you agree that Port Hope is a safe and healthy place to live?
- Nine out of ten (91%) respondents agree that Port Hope is a safe and healthy place to live, including the large majority (73%) who "strongly agree." This is consistent with previous surveys.
- Since this question was introduced in the 2008 survey, results consistently show the large majority of respondents agree that Port Hope is a safe, healthy place to live.


Vision in Motion

- Q. Are you aware of Cameco's Vision in Motion plan?
- Four out of ten (43%) respondents are aware of Cameco's Vision in Motion plan, down from recent surveys.
- The percentage of respondents aware of Cameco's Vision in Motion plan has trended down since this question was first introduced, from 61% in 2017 to 43% in 2022.

4 out of 10 Aware of Vision in Motion Plan




Tracking Awareness of Vision in Motion Plan, 2017 - 2022




Perception of Vision in Motion

- Nine out of ten (93%) respondents agree that Cameco's

- Since 2017, nine out of ten respondents have consistently agreed that Cameco's Vision in Motion plan is a step in the right direction and a benefit for the community.
- Q. Around 7 acres of waterfront land in the harbour area are being turned over to public use as part of the Vision in Motion project. Do you agree these changes are a step in the right direction and benefit the community?
- Nine out of ten (90%) agree that turning over 7 acres of waterfront land in the harbour area to public use as part of Vision in Motion is a step in the right direction and a benefit for Port Hope—including 81% who "strongly agree."
- Since this question was introduced in 2020, nine out of ten respondents have consistently agreed that turning over 7 acres of waterfront land in the harbour area to public use as part of Vision in Motion is a step in the right direction and a benefit for the community.

9 out of 10 Agree Vision in Motion Is Step in Right Direction




9 out of 10 Agree Turning Over Waterfront Land is Benefit to Community



Information from Cameco

- Q. How do you like to receive your information about local current events? What are your preferred sources for local information?
- Respondents indicate using multiple media channels to get information about local current events. The largest percentage (49%) prefer to receive information via letters/flyers/mail, followed by 42% who prefer local newspapers.
- Approximately 32% prefer to get their information from websites and 25% from Port Hope social media groups.
 Another 19% prefer traditional TV/radio sources, 18% community emails and 16% word of mouth.
- Q. Do you think that Cameco makes information about its local operations readily available to Port Hope residents?
- 79% respondents believe Cameco makes information about its operations in Port Hope readily available to residents.
- Since 2006, the majority of respondents have consistently said they think Cameco makes information about its operations in Port Hope readily available to residents.

Respondents Use Multiple Media Channels for Local News



8 out of 10 Think Cameco Makes Information Readily Available




Tracking Perception of Accessibility of Information, 2006 - 2022

Q. Do you recall your household receiving a copy of a newsletter from Cameco?



- Eight out of ten (77%) respondents recall receiving a newsletter from Cameco.
- Recall of the Cameco newsletter being delivered to their households has trended higher among respondents over the last several years, despite a slight dip in 2021.


Majority Read the Newsletter

- Eight out of ten (84%) of those who recall receiving Cameco newsletters say they read them.
- Readership of the Cameco newsletter has remained high since 2009, with between eight out of 10 and nine out of 10 saying they've read the newsletters.


Newsletter Recall & Readership, 2007 - 2022



Community Investment


- Q. Cameco supports a number of community initiatives such as the Northumberland United Way, Northumberland Hills Hospital and others. Were you aware prior to this survey that Cameco invests in the Port Hope area through sponsorships and other community initiatives?
- Nearly all respondents (95%) were aware, prior to the survey, that Cameco invests in the Port Hope area through sponsorships and other community initiatives, including 82% who were "very aware".





- Q. Are you aware that Cameco regularly participates with the public through community events where residents can come and get information about Cameco and its operations in Port Hope?
- 92% of respondents are aware that Cameco regularly participates with the public through community events where residents can get information about Cameco and its operations. This is generally in line with 89% in 2021 and 94% in 2020.

Role of Nuclear Energy in Ontario

- Q. Would you say you are very aware, somewhat aware or not aware that nuclear energy provides more than half of the electricity generated in Ontario?
- Nine out of 10 (90%) respondents are aware that nuclear energy provides more than half of the electricity generated in Ontario including 71% who are "very aware" (up from 65% "very aware" in 2021 and 53% in 2020).


Role of Port Hope in Uranium Processing




9 out of 10 Aware Nuclear Energy Supplies Ontario Electricity



9 out of 10 Aware Ontario Reactors Use Port Hope Uranium






Tracking Awareness of the Role of Nuclear Energy, 2016 - 2022


Aware that Nuclear Energy Supplies Over Half of Electricity Generated in Ontario




Aware that Ontario Reactors Use Port Hope Uranium
